More than 79% of our claims closed without an indemnity payment, and our claims team continued to look after your interests by attending settlement conferences, mediations, and even monitoring trials, when they arose.

The risk management team continued to deliver first-class education with presentations, our first in-person seminar since 2019, and through the Risk Management Consultation Service helpline. Our risk managers fielded calls from more than 3,000 callers to address your questions about COVID and telepsychiatry, information requests, termination, and more. They also spent considerable time addressing practice management trends such as ketamine and psychedelics.

Through our marketing efforts, we continued to increase our digital visibility by launching PRMS on Instagram; if you are an IG user, please follow us (@PRMSPrograms)! Through your referrals of friends and colleagues, PRMS donated more than \$10,000 to 51 organizations dedicated to mental health, and we continued to partner with associations and district branch partners nationwide.

It was a busy yet fulfilling 2022, and I hope you enjoy reading about it as much as we enjoyed executing it.

YEAR IN 2022 REVIEW 2022

A strong defense of our clients is the very foundation of our company. Since our founding in 1986, all claims and lawsuits, whether they are fully defended through trial, mediated, or settled directly, have always been actively managed by PRMS claims staff in full collaboration with our insured psychiatrists. In 2022, we continued

to see a reduction in claims and lawsuits, with 34 claims and lawsuits filed, compared to 70 in 2021, bringing the total number filed since 1986 to 31,139. In 2022, the severity and costs of resolution decreased significantly, while the filing of administrative actions slightly increased

- The average indemnity payment was \$284,143 compared to \$277,606 in 2021.
- » There were 173 administrative actions compared to 178 in 2021.
- » In 2022, 79.7% of all claims and lawsuits resolved without indemnity payment compared to 64.8% in 2021.

RISK MANAGEMENT

Since the onset of the COVID-19 pandemic, PRMS' Risk Managers have continued working tirelessly to share timely resources, support, guidance, and education with clients to help keep their practices and patients safe. In addition to answering more than 3,000 calls on the Risk Management Consultation Service helpline in 2022, our Risk Managers created new educational content, presented to dozens of organizations and residency training programs, and hosted our first in-person seminar in two years, PRMS Mock Trial, in Arlington, VA. New and updated resources, including a "Let's Talk! Telepsych Updates" video, were developed for the new telepsychiatry resources webpage (www.prms.com/telepsych) and made available to the greater mental healthcare community, as well as our network of partners, to support all providers and their patients as practice environments continued to evolve. The telepsychiatry webpage received more than 5,500 visits in 2022.

The Risk Management Consultation Service (RMCS) helpline received 3,194 calls in 2022, the second highest number of annual calls after 2021 by 14, bringing the total number of received calls since 1997 to 68,233. Of that number, 257 were first-time callers. More than 3,900 issues were addressed, and nearly 20% of them related to COVID-19 and telepsychiatry – resulting in 85,501 issues discussed since 1997.

The top five RMCS call topics in 2022, representing more than half of all calls, covered:

- » **18%** COVID/telepsychiatry
- » 14% Information Requests
- » 10% Termination
- » 8% Subpoena
- » **7%** Business


In 2022, Risk Management:

- » Reached more than 2,475 clients and potential clients via in-person (2,044 attendees) and on-demand educational presentations (431 attendees), including:
 - Presented 26 risk management sessions for residency training programs (PREP PRMS' Residents' Education Program) to nearly 400 attendees
 - Presented risk management sessions to various organizations, including 23 APA
 District Branch meetings, 2 AACAP Regional Organizations' programs, and more, reaching more than 1,500 attendees
- » Provided clients with educational and CME on-demand courses through our exclusive PRMS U platform to complete more than 430 total CME courses.
 - 869 clients were first-time registrants
- » Wrote and published beneficial and timely material including:
 - Four articles in the peer-reviewed journal, Innovations in Clinical Neuroscience
 - Two chapters in the textbook, "Malpractice and Liability in Psychiatry" (Springer)
 - More articles on COVID- and telepsychiatry-related issues topics included physician suicide, medication safety, and in-office requirements for telepsychiatrists
 - Three risk management alerts including information and resources related to PHE issues, in-person visit requirements for New York, and DEA issues – shared with clients
 - 12 monthly On Our Minds email digests

CLIENT SERVICES & MARKETING

On the development side, PRMS was busy at work to create new and improve existing features to help make our clients' lives easier.

- » My Program, the exclusive online portal for clients to access policy details and documents, submit changes and payments, and more, received a facelift in 2022! The new My Program is more responsive on mobile devices, has an updated layout with clearer action buttons and additional features, and provides easy access to PRMS U, telepsychiatry resources, and risk management helpline contact information. We hope clients are enjoying the changes and find the updates more organized and easier to access.
- » 2022 also saw the launch of our new Client Online Renewal Application (CORA), where clients can submit their renewal applications to update and provide additional information about practices all paper-free. The secure online application guides clients step-by-step, providing helpful hints and allowing them to upload any pertinent documentation right from their computers.
- » PRMS began taking steps to make ADA-compliant website updates. As an ongoing process, the updates were successfully made in My Program, as well as on the new business and renewal applications in 2022, and we plan to make the rest of the website ADA compliant in 2023.


